## **Modern Day Anti-Slavery Policy.**

### **1. Purpose.**

OpusApeiro Limited is committed to operating with integrity and fairness. We recognise the grave issue of modern slavery and human trafficking, and we are dedicated to ensuring that these practices have no place in our business or supply chains.

### **2. Scope.**

This policy applies to all employees, contractors, suppliers, and partners associated with OpusApeiro Limited.

### **3. Policy Statement.**

- **Suppliers and Partners:** Adhere to this policy and ensure their operations and supply chains are free from modern slavery and human trafficking.

### **6. Due Diligence.**

OpusApeiro Limited will conduct due diligence in our operations and supply chains to prevent modern slavery and human trafficking. This includes:

- **Risk Assessment:** Identify areas where there is a risk of modern slavery and human trafficking.
- **Supplier Audits:** Regularly audit suppliers to ensure compliance with our anti-slavery policy.
- **Contractual Obligations:** Include anti-slavery clauses in contracts with suppliers and partners.

### **7. Training and Awareness.**
